

ELECTION NOTICE

NOGALES UNIFIED SCHOOL DISTRICT NO. 1 GENERAL ELECTION – TUESDAY, NOVEMBER 8, 2016

PUBLIC NOTICE is hereby given that Nogales Unified School District No. 1, County of Santa Cruz, State of Arizona, will hold an election on November 8, 2016. The purpose of the election is to determine whether the District will be allowed to join the Pima County Joint Technical Education District (JTED). Voters must approve their District's participation in becoming part of the JTED and, if approved, the district will become part of the JTED on July 1, 2017.

The proposed JTED would allow Pima County school districts and Nogales Unified School District to combine efforts and offer career and technical education programs.

BALLOT QUESTION

Shall the Nogales Unified School District No. 1 of Santa Cruz County, Arizona, participate in the Pima County Joint Technical Education District (also known as the Pima County JTED) as authorized by state law (A.R.S. §15-395). The property tax rate associated with joining the joint district is \$.005 per \$100 secondary assessed valuation, resulting in a \$5.00 property tax increase per year for a single family home with a full cash value of one hundred thousand dollars.
